This is to inform that the above Management Unit under the Parent Company IOI Corporation Berhad with RSPO membership number 2-0002-04-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit /Surveillance Audit (ASA-02) at Leepang POM and its supply base, located at Lahad Datu, Sabah. The audit will be conducted from 22 - 26 September 2025 against the requirements of:

- RSPO Principles & Criteria 2018


