This is to inform that the above Management Unit under the Parent Company Keck Seng (Malaysia) Berhad with RSPO membership number 2-0094-08-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit (RA-01)/Surveillance Audit (ASA-03) at Masai POM and its supply base, located at Masai, Johor. The audit will be conducted from 6 - 10 October 2025 against the requirements of:

In brief, Keck Seng (Malaysia) Berhad is a public listed company on the Main Board of Bursa Malaysia and one of its activities is an integrated palm oil producer. Keck Seng (Malaysia) Berhad owns and operates one palm oil mills (Plantation Management Unit) and 10 estates in Malaysia.


