The product is approximately 74 inches long by 27 inches wide by 36 inches tall and weighs about 189 lbs. The grills have a silver color label located on the rear with SKU Number as 1DFL42LLA., These products are labeled and using a cETLus Certification Mark control number 5015097. Hazard Involved
